## Minutes for October 2025

### **Treasurer Report: Ed B, Jr.**

July Financial report was presented and explanation of question from last month regarding Total Cost of Goods was given. The report was correct. Report Accepted as presented. August Financial report was presented and reviewed. The report was accepted as presented. The reports submitted for approval are summary reports, as previously requested by Council. Ed announced that he has copies of the full report available to anyone who wants one. Question was asked about whether the Intergroup makes contributions to General Service and Area 54. Intergroups and Central Offices are not a part of the AA structure. General Service does not expect donations from Intergroups. At times we have made donations when we had more than our Prudent Reserve, and that was approved by council. At the end of a year, if we have a gross surplus Council could vote to donate. In the past we have donated to other Intergroups before donating to General Service. Discussion about terminology in our reports using Non-profit language, i.e. surplus instead of profit. Our present accounting system is not for a non-profit therefore non-profit terms are not in the reports. We would have to change to a completely different system to change the terminology. Also, the General Service raised the amount that can be left in a will from \$10,000 to 12,500. An individual can donate \$7,500 per year.

**Secretary Report: Judy K.**

The September Minutes were presented. Reading was waived. Minutes were approved with one correction. Change Dorsey Pearson to Doug Pearson. Minutes were accepted.

**Executive Board Report: Tony T**

Update on progress at our new location. Above All Construction has completed demolition and has framing in for the walls. Examples of the signage for the new building was presented. Construction is due to be completed around mid to late November and we have contracted with the moving company who will move everything. The anticipated move will be the first to mid-December. The stained glass is being dismantled and repaired and installed at the new location on the Archives side of the new sight. The committee in conjunction with the Archives committee also is developing software requirements for the touch screens and multi-media displays we will be using in the new location.
