Calls for Information in November were 9, 12-step calls were 1, calls that were hang ups or dead air were 59. We have been getting a lot of dead air calls all day. We will use the answering service during the move.

After our last meeting people did go out to see the new location. New safety glass has been installed where the stained-glass window will go. Volunteers put up shelves in the committee room, Founder's Day room, and the Archives. New signs are made for the front and we are waiting for them to be installed. There will also be a sign on Romig Road. We met with the Fire Marshall last week. Above All Construction workers are all in the Fellowship and they did a lot of extra work for us, so we want to thank them.

Information Technology -Ed F

The IT Committee did not meet formally in November or December but instead met to complete the network tasks at the new office. All the network wiring is now complete. The security cameras and computer equipment will be moved and setup at the beginning of the week. The copier machine is under lease. The leasing company is scheduled to move it to the new location on Thursday. Our next meeting will be Tuesday, January 13 at 6 PM.
